1. RULES: The regatta will be governed by the Racing Rules of Sailing (RRS) for 2009-2012, the prescriptions of US Sailing, the ISSA Procedural Rules, the rules of the Vanguard 15 class; and this Notice of Race (except as any of these are changed by the Sailing Instructions); and by the Sailing Instructions

2. ELIGIBILITY, ENTRY & ENTRY FEE, REGISTRATION

2.1 This regatta is open to all High School Teams

Teams may enter by filing an entry with the Seattle Yacht Club Sailing Office using the accompanying Entry form. Entry fee may be paid on regatta day.

2.2 All Competitors must sign the liability release form.

2.3 Entry Fee: The entry fee is \$15.00 per competitor, Make checks payable to Seattle Yacht Club. Fee will include continental breakfast and lunch buffet.

2.4 Entry fees will be waived for teams who bring their own Vanguard 15(s).

2.5 Schools may enter as many teams as they chose. If your school does not have sufficient sailors to form the necessary teams, you may "mix and match" sailors from different schools. If your school has more than one team please enter as team 1, 2, 3 etc.

3. BOATS:

3.1 Seattle Yacht Club will provide 12 Vanguard 15s. Please let us know if you can bring more Vanguard 15s.

3.2 Entries will be limited to this number of teams unless more boats can be brought by other organizations. Please notify Ben Glass if you plan to bring boats at (206) 437-5848 or by email at beglass@gmail.com.

3.3 The Regatta will be sailed with one division on the water at a time.

3.4 Rotations will be every 2 races from the end of SYC Dock #2.

6. SAILING AREA: Races will be held in Portage Bay between the University Bridge, Montlake Bridge and 520 Bridge.

7.1 The low point scoring system, rule A2, will apply, with one full rotation scheduled of which three races must be completed to constitute a series. Each team score will be the sum of the "A" & "B" scores in all races.

Release of Liability and Hold Harmless Agreement

I am the parent or legal guardian of _____,

The term of this agreement shall be one year, unless earlier terminated by written notice to SYC, except that it shall not expire or terminate as to occurrences while it is in effect.
